## REFLECTIONS

## TRUE STORY...

At the prodding of my friends I am writing this story. My name is Mildred Honor. I am a former elementary school music teacher from Des Moines, Iowa. I have always supplemented my income by teaching piano lessons... Something I have done for over 30 years. During those years, I found that children have many levels of musical ability, and even though I have never had the prodigy, I have taught some very talented students. However, I have also had my share of what I call "Musically Challenged Pupils".

One such pupil being Robby. Robby was 11 years old when his Mother (a Single Mom) dropped him off for his first piano lesson. I prefer that students(especially boys) begin at an earlier age, which I explained to Robby. But Robby said that it had always been his Mother's Dream to hear him play the piano, so I took him as a student.

At the end of each weekly lesson he would always say 'My Mom's going to hear me play someday.' But to me, it seemed hopeless, he just did not have any inborn ability. I only knew his Mother from a distance as she dropped Robby off or waited in her aged car to pick him up. She always waved and smiled, but never dropped in.

Then one day Robby stopped coming for his lessons. I thought about calling him, but assumed that because of his lack of ability he had decided to pursue something else. I was also glad that he had stopped coming. He was a bad advertisement for my teaching!

Several weeks later I mailed a flyer recital to the students' homes. To my surprise, Robby (who had received a flyer) asked if he could be in the Recital. I told him that the Recital was for current pupils and that because he had dropped out, he really did not qualify. He told me that his Mother had been sick and unable to take him to his piano lessons, but that he had been practicing. 'Please Miss Honor, I've just got to play,' he insisted. I don't know what led me to allow him to play in the Recital – perhaps it was his insistence or maybe something inside of me saying that it would be all right.

The night of the Recital came and the high school gymnasium was packed with parents, relatives and friends. I put Robby last in the program, just before I was to come up and thank all the students and play a finishing piece. I thought that any damage he might do would come at the end of the program and I could always salvage his poor performance through my 'Curtain Closer'.

Well, the Recital went off without a hitch, the students had been practicing and it showed. Then Robby came up on the stage. His clothes were wrinkled and his hair looked as though he had run an egg beater through it. 'Why wasn't he dressed up like the other students?' I thought. 'Why didn't his Mother at least make him comb his hair for this Special Night?' Robby pulled out the piano bench, and I was surprised when he announced that he had chosen to play Mozart's Concerto No.21 in C Major. I was not prepared for what I heard next. his fingers were light on the keys, they even danced nimbly on the ivories. He went from Pianissimo to Fortissimo, from Allegro to Virtuoso; his suspended chords that Mozart demands were Magnificent! Never had I heard Mozart played so well by anyone his age.

After six and a half minutes, he ended in a Grand Crescendo, and everyone was on their feet in Wild Applause!! Overcome and in tears, I ran up on stage and put my arms around Robby in joy. "I have never heard you play like that Robby, how did you do it?' Through the microphone Robby explained: 'Well, Miss Honor, remember I told you that my Mom was sick? Well, she actually had cancer and passed away this morning. And well... she was born deaf, so tonight was the first time she had ever heard me play, and I wanted to make it Special.'

There wasn't a dry eye in the house that evening. As people from Social Services led Robby from the stage to be placed in to Foster Care, I noticed that even their eyes were red and puffy. I thought to myself then how much richer my life had been for taking Robby as my pupil.

No, I have never had a Prodigy, but that night I became a Prodigy... of Robby. He was the teacher and I was the pupil, for he had taught me the meaning of perseverance and love and believing in yourself, and may be even taking a chance on someone and you didn't know why.

Robby was killed years later in the Senseless Bombing of the Alfred P. Murray Federal Building in Oklahoma City in April, 1995.

So many seemingly trivial interactions between two people present us with a choice. Do we act with compassion or do we pass up that opportunity.

Thank you for reading this... !! May God Bless You Today, Tomorrow and Always. If God didn't have a Purpose for us, we wouldn't be here!

Live Simply. Love Generously. Care Deeply. Speak Kindly. Leave The Rest To God.

I received this from a cousin and thought it was very special to share with all of you.

# **Pastor's Notes**



*Make every effort to keep the unity of the Spirit through the bond of peace.* <sup>4</sup> *There is one body and one Spirit, just as you were called to one hope when you were called;* <sup>5</sup> *one Lord, one faith, one baptism. Ephesians* 4:3-5

A few weeks ago we had a congregational meeting to look at moving ahead with one of two possible building expansion options. Both the north option and the south option did a good job of addressing a number of needs that we have identified as a congregation. The architect had given us a ball park figure of around \$300,000-\$500,000 depending on which option we chose. Prior to the meeting we got more detailed building cost estimates from three contractors based on the preliminary plans developed by the architect. I think both the building coming and the church council were somewhat blown away by the cost projections ranging from slightly under \$400-000 to something less than \$700,000. In addition, the architect had projected the proposed south addition would be less costly than the north addition to build when in reality the south addition estimates were far more expensive than the north addition. When we presented the cost estimates at the congregational meeting I think members of the congregation were also surprised and a bit confused when the numbers were presented. We had planned to take two votes by secret ballot: the first to move ahead or not move ahead on one or the other building options presented; the second vote to move ahead with the north addition or the south addition. I think all of us were somewhat overwhelmed by the cost or either option so the first vote was much closer than any of us on the council or building committed had expected. The majority had voted to move ahead but it was not an overwhelming vote of support to move ahead. And because of the closeness of the vote I was deeply concerned that moving ahead with either of the proposals might become a divisive issue for us as a congregation. And I didn't want that to happen so I moved that we table the whole issue to another meeting. I wanted us to make every effort to keep the unity of the Spirit through the bond of *peace* on this issue therefore my motion to table the project to another time.

Unity in a congregation can be a very fragile thing. The Lord has blessed us with a marvelous sense of unity here at St. John's and I didn't want us to risk losing that. No building program is worth losing that sense of unity. I do believe that we have some very real space needs that need to be addressed and I believe that at some point in the near future we can agree on how to meet those needs and do so with a near unanimous agreement on how to do it. And when that day comes we will be able to move ahead with great peace and assurance that God will bless our efforts and provide the financial means to implement those plans. Until that day we are content with expanding our parking lot and doing so in a very cost effective way. I love this congregation and I will do everything in my power as your Pastor to promote a spirit of peace and unity in our congregation as Paul urges us to do in Ephesians chapter 4! ## August 11, 2015

Council Members Present: All members and Pastor Bob were present with the exception of Gene Konerza.

Dave called the meeting to order.

Pastor Bob opened the meeting with prayer and a devotional taken from John 6:33.

The secretary's minutes were approved from the July meeting.

Brian gave the treasurer's report which showed a beginning balance of \$30,919.57 and an ending balance of \$21,434.81 after the transfer of \$8,000.00 from the general to the building fund. This report was approved as given.

Gene called the church and reported that the Building Fund has a current balance of \$71,502.71 after the transfer of \$8,000 from the general fund. This report was approved as given.

## **Old Business:**

-- Building Investigation Committee: Met with an engineer, discussed the absentee vote, reshaped the overflow parking and are getting quotes with and w/o gravel.

-- 150<sup>th</sup> Anniversary Planning Committee: Plans are going well. Doing ok with the history of the church; plans are to get a bounce house and inflatable obstacle course; will be selling ornaments as well as pictures; and program is being work on for that day.

-- Congregational meeting 9-27-15 to include: building addition vote, parking lot addition vote, constitution changes and financial policy change.

-- Pam has reviewed the policy book and is hoping to have it organized by the next meeting.

-- Dave has ordered samples of communion cups – both are different from what we have. He will keep looking into.

-- Door bolt guard has been installed on the west door and the east door will be getting done soon.

-- On 7-26-15 at a special meeting after the service, the council approved another volunteer candidate based on their background check.

- The cemetery committee is considering the purchase of a small "shed" or storage container to put ornaments into that need to be removed for lawn mowing. It may be placed behind the granary.
- A quote will be gotten prior to the congregational meeting as to what additional lawn mowing charges would be if the additional parking lot is approved and would be planted into grass.

There were two suggestions in the box. 1) We would like to see church service stay at 9:30 and Sunday school at 10:30. It is very noisy and distracting prior to the church service while Sunday school is finishing up their singing. Church at 9:30 would eliminate it. Thank you. *The council discussed and did not take action. It may be something that may want to get brought up at the congregational meeting for discussion.* 2) On Sundays when there are apt to be extra guests due to something special going on besides Easter and Christmas, could we put in parenthesis (debts and debtors) to let the guests know that at St. Johns we say the Lord's prayer using these words instead of trespassed and trespass. Guests would not be slightly embarrassed by saying it different that the rest. I am glad that we do it the way that we do. *Pastor Bob and the council agreed that we could just make it a part of the bulletin each week*.

## St John's Special Congregational Meeting Sunday, September 27<sup>th</sup>, 2015

Following our regular church service, a special congregational meeting was called to order by President of the council, Dave Swift. Pastor Bob opened the meeting with prayer. This meeting was called to vote on the building and parking lot addition, and to discuss constitution and financial policy changes.

The constitution vote was deferred as we needed one half of our membership present which is 65 and there were only 55 present.

Dave explained the following changes relating to the financial policy:

- 1) Proposing a \$5,000 expense limit instead of the current \$3,000 when congregational authorization is required. Insurance payments and the pastor's salary are approaching or hitting the \$3,000 limit.
- 2) Changing the number of people on the audit committee to be consistent to what has been working well.
- 3) Clarification of audit committee's responsibilities.
- 4) Rewording for clarity.
- 5) Adding verification of two signatures when expense limit is met.

Brenda Schaefer made a motion that St. Johns adopts the proposed changes to the financial policy as presented and Randy Knick seconded the motion. The congregation voted and motion was passed.

Discussion was made on the parking lot expansion. It was recommended that the expansion be grass only. With the three bids that came in costs with a gravel lot were \$14,400 to \$34,500. Without gravel they came in at \$2,900 to \$6,500. Costs included site preparation, seeding plus planting. The extra mowing cost would be \$50/mow. A question was asked regarding any additional tiling that would be needed. All the contractors thought there was enough slope and no additional tiling would be needed. A motion was made by Jon Block and seconded by Jerry Block to allow the Council to proceed with getting a 1 acre grass overflow lot made, selecting the most appropriate bids and not to exceed the cost of \$6,000. Congregation approved.

The congregation discussed various topics regarding the addition to St. Johns. The numbers came in around \$250k more for the south addition vs. the north. After a vote was taken and counted, there were 35 yes votes and 20 no votes. Pastor Bob suggested that we hold off on moving ahead until there is a more unanimous vote one way or the other. He did not want the church divided over this project. A motion was made and approved to table the consideration of the building plans until a later date. Discussion was made as to how to get more of the congregation to a meeting so that there would be more input. Absentee ballots are not allowed as per our constitution. The possibility of opening up the sanctuary back into the overflow area was also looked into. It was determined that this could be done but this would also be tabled until a later date. How to make room for Sunday school/Adult Bible study on Sunday mornings needs to be thought of.

A motion was made, seconded and approved to adjourn the meeting.
